CIRCULAR

(For the Postgraduate Programs of 2024 scheme)

Sub: **Revised Academic Amendments for Continuous Internal Evaluation for the 2024 Scheme of M.Tech & MCA Programs w.e.f ACY 2024-25 Odd semester.**

Ref: Resolutions made in the 53rd Exam Board Meeting held on 4th Dec 2024.

Students belonging to 2024 scheme of M.Tech & MCA Programs, are hereby asked to note the **revised academic amendments** with regard to **Continuous Internal Evaluation (CIE) which will be implemented from the ACY 2024-25 odd semester onwards.**

1. The CIE component will have **three** sub components:
 - A. Tests.
 - B. Quizzes &
 - C. Experiential Learning.
2. The weightage for the individual components would be:
 - A. Test for **40%** of total marks.
 - B. Quizzes for **20%** of total marks.
 - C. Experiential Learning for **40%** total marks.
 - D. Lab component for **the maximum marks of 50.**

Revised CIE Guidelines:

1. Henceforth, **earning 50% marks in components A & B put-together is mandatory to get eligibility to write SEE.**
2. Marks towards Experiential Learning Component [C] will be added to components [A] and [B] to get the final CIE. Minimum criteria is not required for this component [C].
3. **Minimum of 50% out of total CIE (Components [A], [B] & C put-together) to be maintained to get eligible to write Semester End Exams (SEE).**
4. For the lab component, earning minimum of 50% out of maximum lab marks is mandatory to get eligibility to write SEE.
5. **This will come into effect from ACY 2024-25 onwards (odd sem)**

The Controller of Examinations welcome the members for the meeting and following points were discussed:


Agenda No. 262	To read and record the minutes of the previous board meeting – (By circulation).
	<ul style="list-style-type: none">The Controller of Examination read and record the minutes of the 52nd meeting by circulation on 26.07.2024.
Agenda No. 263	Result analysis and Approval of PG – M.Tech & MCA, Rank and Graduate list of 2022-24 batch.
	<ul style="list-style-type: none">Result analysis is presented by Controller of Examinations for all PG programs. The members opined based on the result analysis presented, the number of First class with distinction (275 out of 297 students) is comparatively high.The chairman of examination board asked Controller of Examinations to collect the details of publication of research papers generated out of PG projects to ascertain the quality of PG projects. Also chairman suggested to bring this matter related to results in HoD's meeting to discuss.
Agenda No. 264	Information regarding PG - M.Tech & MCA, 14 th Graduation Day 2023-24 (Part-II).
	<ul style="list-style-type: none">The chairman of Examination Board informed to committee that on 17th December 2024 Graduation day (Part-II) for PG students will be organised at 4.30 PM in IEM auditorium, RVCE. Candidate with Two guests are allowed to participate in the program. Candidates are only permitted in IEM auditorium and the guests have to see the live telecast of the program in other seminar hall in the campus (Dept., BT, CV & MCA)Out of 351 (No of Students admitted) 297 students have completed the required number of credits and are eligible for award of degree.

Agenda No. 265	Discussion on Amendment of Malpractice Regulations.
	<ul style="list-style-type: none"> Regarding the repeated indulgence in malpractice in the same are subsequent examinations (point no. IV of guidelines for recommending penalties and punishments to the students involved in Malpractices during examination, the proposed additions is rejected by the committee as a whole. It is also recommended by the committee to implement the punishment the point (a) (Denial benefit of the performance), shall be implemented strictly whenever the malpractice case consideration committee recommends. <p>The chairman informed to committee that there may be few changes in the autonomous regulations going to be proposed by VTU shortly.</p>
Agenda No. 266	Discussion on to take Non-Disclosure Agreement (NDA) from employees involving in Examination related confidential work.
	<ul style="list-style-type: none"> The committee recommended to take Non-Disclosure Agreement (NDA) from Examination unit coordinators and employees of CoE's office. Based on the duties and responsibilities of each, the draft NDA will be prepared and once it is approved by authorities it shall be implemented. It is decided to appoint a Chief exam unit coordinator to bring more accountability among the coordinators and also to monitor the activities in valuation unit by CoE. It is decided to inform through CoE's to all exam unit coordinators to follow strictly the norms and process to conduct the evaluation.
Agenda No. 267	Discussion on SAP issues related to Examination and Evaluation.
	<ul style="list-style-type: none"> The chairman agreed few issued in SAP, related to examination and evaluation and it will be sorted out by calling a meeting with Deputy Director, RVIC shortly.
Agenda No. 268	Discussion on preparation to implement the system to generate SEE question paper from question bank.
	<ul style="list-style-type: none"> The CoE presented the developments related to implementation to system to generate SEE question paper from question bank. The chairman suggested to call a meeting in the 2nd week of December 2024, of all HoD's to inform them the requirements and modalities of question bank to be prepared.
Agenda No. 269	Discussion on consideration of NPTEL courses to revise the Examination fees for PG - 2024 scheme.
	Based on the discussion to decide to go with the same examination fees without any amendment.
Agenda No. 270	Any other points with permission from the chair.
	<ul style="list-style-type: none"> A Summary report of Examination process and quality auditing is presented by CoE with list of experts attended for Examination process and quality auditing. The CoE also presented the abstract of observations. Chairman opined that to call experts from NIT's and other reputed institutions for exam auditing so as to understand the best practices adopted in those institutions. Dean academics proposed the committee regarding change in the regulations of minimum requirements to write SEE. According to the new amendment a candidate to be eligible to write SEE 40% of minimum marks shall be scored other than EL component also. It will be applicable to all the students of 2022 scheme of UG and 2024 scheme of PG. Dean Academics proposed that Laboratory SEE shall be conducted through project based assessment for UG 2022 scheme & PG 2024 scheme. During the discussion CoE opined that students must be aware the process and what type of questions in the new method of assessment they have to face during

SEE laboratory examination. Therefore, the above mentioned matter must be informed to all the students in advance.








- For the students of 2022 scheme and onwards as per the autonomous norms the branch change students have to take one additional course (Professional core course) if they have not studied before branch change.
