(57) Abstract:

ABSTRACT A wheel hub drive assembly comprising a wheel hub, at least one driving electric motor, a compound planetary gear unit includes at least two sets of gear pairs, first gear pair including a sun gear and first set of planet gears operative at first transmission ratio, second gear pair including second set of planet gears and a ring gear operative at second transmission ratio, a polygon coupling unit configured to couple a claw carrier with the wheel hub, wherein the male polygon profile of the polygon coupling is provided on the claw carrier includes multiple lobes for transmitting high torque with low stress and mates with a female polygon profile on the wheel hub to lock relative motion and a steering knuckle houses all the components and having provision for mounting a spring-damper on top and a lower wishbone at bottom.
