(57) Abstract :

A system for authentication comprising a terminal device accessing a resource, a plurality of biometric sensors capable of sensing one or more biometric parameters including fingerprints and Iris, the plurality of biometric sensors connected to the terminal device, an authentication unit authenticating the biometric parameter for accessing the resource generating a first result representing successful authentication and a second result representing the unsuccessful authentication, wherein the authentication unit not performing mapping of a prior data representing a prior biometric parameter with biometric parameter, and an access controller controlling the access of the terminal device to the resource unit based on the first and the second result of the authentication unit.
