- E) The doors shall not be kept locked / latched during working hours and shall be free from obstruction.
- F) During the class hours the class room doors shall not be locked from inside to outside.
- H) As per Honorable Supreme Court order all teachers and staffs shall be trained to handle safety equipment, initiate emergency evacuation and protect their students in the event of fire and other emergency and the school shall observe the Fire Safety Day on April 14<sup>th</sup> of every year be conducting Fire Safety drills with co-ordinate Fire Service department.

Under the above circumstance, the Karnataka Fire & Emergency Services Department is issuing Fire Safety Recommendation to "Cauvery Block (Hostel Block), M/s RV College of Engineering, RV Educational Institutions, RV Vidyaniketana Post, Mysore Road, Bangaluru-560 059" subject to condition stipulated above and compliance of the above recommendations as shown in Column-4 of serial-B within 3 months and compliance should be obtained from the undersigned.

"<u>This Fire Safety Recommendation is valid for Only One Year from the date of issue</u> and it is renewable.

All requirements recommended above are as per National Building Code-2016 Part-4 clause 3.1.6 of Fire and Life safety will have to be complied with mandatorily.
