This has reference to NBA's letter of even number dated 18-01-2018 under which some of PG Engineering programs offered by your institution were granted provisional accreditation for 2 years upto 30-06-2019 in Tier-I by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where PG Engineering programs of an Institution were granted provisional accreditation for a period of 2 years, the period of accreditation of these programs shall be extended from 2 to 3 years subject to the condition that they meet the Pre-visit qualifiers. The Pre-qualifiers submitted by R.V. College of Engineering, 8th Mile, Mysore road, R.V. Vidyaniketan Post, Bangalore-560059, Karnataka have been considered. The following PG Engineering program(s) meet all the essential parameters of pre-visit qualifiers. Accordingly, the competent authority in NBA has approved the following accreditation status to the program(s) as given in the Table below:
