Sub: Special Provision for students admitted under 2015, 2017 and 2018 VTU -Reg Ref:

1. RVCE/DA/1051/2022-23 Dtaed: 13 Sept 2023; registration for fast track semester.

2. VTU/BGM/Aca-Cirs/SA/2023-24/3017 Dated:5 Sept 2023

With reference to the recent notification received from VTU as stated above, a Special One-time provision has been made for students admitted during 2015,2017 and 2018.

As a Special One-time Provision.

- Students who have completed the courses up to the final semester (8th for B.E.) and are left with backlogs satisfying the minimum CIE marks, may be permitted to register directly to SEE for ANY NUMBER OF COURSES (maximum number of credits are relaxed) during the upcoming fast track semester. (Ref no. 1).
 - a. Such of those students (coming under the above clause) need to register in the link only as mentioned in the circular.
 - b. Separate link for the payment of the examination fee will be shared shortly.
 - c. The examination fee receipt and the PDF of the registration form to be submitted to the office of the Dean Academics in person to check the course code and eligibility.
- Students who have completed the courses upto the final semester and are left with II. backlog courses without satisfying the attendance and CIE requirements, may be permitted to re-register for ANY NUMBER OF COURSES (maximum number of credits are relaxed) and earn both CIE and attendance and then appear for the SEE.
 - a. Such of those students should register and make the payment in SAP portal only.

b. Both the tuition fee and examination fee are applicable.

c. The fee receipt and the PDF of the registration form to be submitted to the office of the Dean Academics in person to check the course code and eligibility.

Both I and II are subjected to the permitted maximum duration of the III.

Special Provision for students at Autonomous Colleges admitted under 2015,

2017 and 2018 VTU Regulations to appear for summer semester - reg...

Preamble:

A Few students admitted to the Autonomous colleges under 2015, 2017, and 2018 Regulations and completed all the 8/10 semesters (8th for B.E. and 10th for B.Arch.) have given representation to the concerned College Principals requesting them to appear for all backlog papers at a time. The College in turn forwarded the request to the University. The request was placed before the Autonomy Guidelines Committee (ref. 1 and ref.2), and on approval of the recommendations by the Hon'ble Vice Chancellor, the following is informed.

Special One-Time Provision for students at autonomous colleges admitted during 2015, 2017 and 2018:

- (a) For students admitted under 2015, 2017, and 2018 Regulations, a student having an 'F' grade in any course, shall re-register for that course in the summer semester, obtain the attendance and CCE (Continuous Comprehensive Evaluation), and appear for the SEE. The maximum permitted credit for re-registration during the summer semester is limited to 16.
- (b) As a special provision,
 - i. Students who have completed the courses up to the final semester (8th for B.E. and 10th for B.Arch.) and are left with backlogs satisfying the minimum CCE marks, may be permitted to register directly to SEE for any number of courses during the summer semester, offered at the end of 8th semester.
 - ii. Students who have completed the courses up to the final semester (8th for B.E. and 10th for B.Arch.) and are left with backlogs without satisfying the minimum CCE marks, may be permitted tore-register for any number of courses (i.e., the maximum number credits are relaxed) for

Sub:Registration for Fast-Track Semester (Phase-II) for the Academic year 2022-23.

The registration process and the schedule of activities for Fast-Track semester are given below:

BE Programs:-

- 1. Students of 2016 SCHEME can register for the failed COURSES, not exceeding 25 credits & not more than two courses with labs;
- 2. Students of 2018 SCHEME can register for maximum of FOUR COURSES ONLY, not exceeding 16 credits & not more than two courses with labs;
- 3. Total no, of courses with Phase-I & II put together Four Courses only.

4. All courses from I to VIII of 2018/2016 will be offered.
