Pursuant to the approval of University Grants Commission Ref. (2), in exercise of powers conferred upon Visvesvaraya Technological University by the VTU ACT & Statutes cited vide Ref (3) above, the **RV College of Engineering, Bengaluru** is granted '**Extension of Autonomous Status**' for a period of five years from the session 2019-2020 to 2023-2024 subject to the following conditions.

Conditions:

1. The College shall abide by the clause enumerated in UGC letter at Ref (2).
2. The College shall abide by the provisions of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 and amended from time to time.
3. The College shall strictly abide by the Act, Statutes, Guidelines for Implementation of Academic Autonomy, Rules and Regulations of the Visvesvaraya Technological University (VTU), Belagavi as when it is revised/amended from time to time.
4. The College shall get its programmes accredited by the National Board of Accreditation (NBA) and National Assessment and Accreditation Council (NAAC) as and when it is mandated by the UGC, AICTE and VTU.
5. The College shall send annual returns to the University every year by 31st March in the format prescribed in Guidelines for Implementation of Academic Autonomy.
6. The College shall send the list of admitted candidates to the University for Approval and generation of University Seat Numbers immediately after reconciliation against the University notification in this regard.
7. The College shall not permit any student to appear for the examination without the admission approval of University.

14. The College needs to pay One Time Affiliation Fees as prescribed by the University notification vide: VTU/Aca/A12/2019-20/1660, dtd: 13.06.2019 and notified in this regard from time to time.
15. The College has to initiate steps to notify the Extension Status of Autonomy for its Stakeholders with Intimation to the State Government & University.

NOTIFICATION.

Ordered that the Mysore State Forest Act, 1963 which received the assent of the President, on the Twenty-sixth day of January 1964, be published as Mysore Act No. 5 of 1964, in the *Mysore Gazette*, for general information.

NOTIFICATION.

S. O. 275—In exercise of the powers conferred under Section 44-A of the Mysore University Act, 1956, as amended by the Mysore University (Amendment) Act, 1957, the Government of Mysore are pleased to sanction affiliation of the Rashtreeya Vidyalaya College of Engineering, Bangalore, to the Mysore University for teaching First Year of the Five-Year Integrated Course in Engineering for the year 1963-64, with a total intake of 120 students, subject to the conditions laid down in the report of the Local Inquiry Committee and subject also to the following further conditions, viz. :

- (1) the Management of the College should deposit immediately with the Mysore University a sum of Rs. 5 lakhs;
- (2) the Management should agree to abide by the conditions that might be prescribed by the State Government in consultation with the University regarding the Governing Body of the College and admissions to the College;
- (3) the deposit made with the University should ultimately be raised to Rs. 25 lakhs in due course; and
- (4) there shall be no financial commitment to Government.
